

## SEND and Inclusion Action Plan - 2023-2024

## **School Context**

Starbeck is a one form entry average sized primary school. The percentage of pupils eligible for free school meals (29.4%) is above national average of 23.8% (June 2023). The number of children from ethnic minority groups (14%) is much lower than national averages (33.9%). The percentage of children on school support on the SEND register (10%) is just below national (13%). The percentage of children with an Education Health Care Plan (6.6%) which is in line with national averages (4.3%).
